8. Committee Business

8.1. Reports to Committee

a. Town of Erin – New Municipal Supply Well

Patty Meyer, Senior Hydrogeologist with Aqua Insight Inc., provided an overview of the source protection technical work completed for the Town of Erin's new well E9. CTC staff followed with an overview of the amendment process to incorporate this technical work into the CTC Source Protection Plan and consultation timelines. P. Meyer, CTC and Wellington Source Water Protection staff and the Town of Erin Mayor addressed Committee questions about the technical work, drinking water threats, need to bring the new well online by 2025, impacts and support for affected landowners, scope of amendment, and upcoming consultation. C. Gerrits expressed interest in further discussion on whether both closed and open-loop geothermal systems should be considered a transport pathway.

- AND FURTHER THAT staff be directed to take the necessary actions to prepare the final amendments package for the Proposed Credit Valley Assessment Report and Proposed CTC Source Protection Plan, for submission by the Credit Valley Source Protection Authority, to the Ministry of the Environment, Conservation, and Parks.

c. Importation of excess soil into a Well Head Protection Area

CTC staff provided an overview of municipal concerns to drinking water sources in the Town of Orangeville in relation to the rehabilitation of an inactive aggregate pit through the importation of excess soil. The Committee discussed the current regulatory regime and whether the Committee has a role in addressing the concern about importation of excess soil in well-head protection areas. The importation of excess soil as a local threat was discussed as an avenue to address this perceived threat via policy within the CTC Source Protection Plan. An amendment to consider a local threat was added to the resolution.

THAT the CTC Source Protection Committee direct CVSPA staff to send a letter to the Ontario Minister of the Environment, Conservation and Parks, and the Minister of Natural Resources and Forestry, requesting both ministries to take steps to address the concerns raised by Amaranth and Orangeville on the application for significant amendment to the Aggregate Resource Act Licence No. 3573 (ERO# 019-8143), and to review the existing regulatory framework for governing excess soil in wellhead protection areas, and address gaps in the Clean Water Act, Excess Soil Regulations, and Aggregate Resources Act to ensure the protection of municipal drinking water sources;

AND FURTHER THAT the CTC Source Protection Committee direct CTC staff to develop appropriate policies directed at the Ministry of Natural Resources and Forestry for updating all existing aggregate licences across the CTC Source Protection Region to include the latest approved mapping of applicable Wellhead Protection Areas;

AND THAT CTC staff be directed to report back to the CTC Source Protection Committee with a recommendation on whether to pursue importation of excess soil in well-head protection areas as a local threat.
